POLICY AND GUIDELINES FOR SPORTSFIELD USE

1. Only THCA residents and their guests may use both Park active and passive areas, and the Park Sportsfield, either by reserving with a use permit or on a first-come, first-serve basis if not previously reserved.
 - a. Park Sportsfields are open from 6AM to 10PM. Use from 10PM to 6AM is prohibited unless authorized in writing by THCA.
 - b. No person shall drive or otherwise operate a vehicle in the Park Sportsfield upon surfaces other than those maintained and open to the public for purposes of vehicular travel. The only exceptions are: vehicles in service of THCA, law enforcement vehicles, emergency vehicles, or those specifically authorized.
 - c. No person or group may install, use, and/or operate within Park Sportsfield a loudspeaker or any sound amplifying equipment for any purpose, except when installed, used or operated in compliance with one of the following provisions: By law enforcement personnel; THCA Staff, or with express permission of THCA.
 - d. Fundraising efforts may be authorized for non-profit youth sports organizations with express permission of THCA.
 - e. No person, group or organization shall make any modifications or additions to anything in the Park Sportsfields, unless specifically authorized in writing by THCA.
 - f. The practicing or playing of golf on any Park Sportsfield is always prohibited.
 - g. No person shall carry or discharge firearms, firecrackers, rockets, torpedoes, or other types of explosives: or carry or discharge any gun, pistol, slingshot or similar devise, or any bows and arrow, or carry or use any other object capable of propelling a projectile; or carry or use any object calculated or likely to make a noise sufficient to disturb the peace or quiet of the park users or the park; or bring into the Park Area or Park Sportsfield any of the above objects or articles.
 - h. Inclement weather is defined as weather which, in the sole judgment of THCA, would leave a Park Sportsfield in a condition that would present a risk of damage to the Park Sportsfield or injury to the user. THCA has the authority to close all or any portion of a Park Sportsfield to a user based on inclement weather.

- i. The use of illegal drugs on any Park Sportsfield is prohibited.
 - j. USERS MUST INDEMNIFY AND SAVE THCA HARMLESS FROM ANY LOSS OR DAMAGE TO PERSONAL PROPERTY BY FIRE, THEFT, OR FROM ANY CAUSE WHATSOEVER AND TO INDEMNIFY AND SAVE THCA HARMLESS FROM ANY AND ALL LIABILITY FOR INJURY OR DEATH OF ANY PERSON OR PERSONS, OR LOSS OR DAMAGE TO ANY PROPERTY CAUSED OR OCCASIONED BY, OR ARISING OUT OF THE USE OF THCA RECREATIONAL FACILITIES OR DESIGNATED FACILITIES. BY THE USER OR, THE USER FAMILY, GUEST(S) AND/OR INVITEES.
2. All organized and structured organizations that wish to use the Park Sportsfields on a continuing basis must first have the use approved in writing by THCA. For reference purposes, the area for use of the Sportsfield is limited to no more than one third of the Sportsfield.
 3. THCA residents must be current on all assessments, late charges, and interest fines to receive a Use Permit.
 4. The approval of Park Sportsfield Use will be determined in accordance with user group priority rankings as follows:

5. Use Fees. There is no charge to THCA residents for use of the Park Sportsfield. For reference purposes, a field is defined as no more than one third of the entire Sportsfield. Fees for organized sports will be charged as follows:

Youth Soccer	Ages 7 and under	\$500 fee per field, per season AND \$500 deposit per field, per season
	Ages 8 and older	\$1,000 fee per field, per season AND \$1,500 deposit per field, per season
Youth Basketball		\$100 fee per season
Adult Soccer		Not allowed at this time
Adult Basketball		\$200 fee per season

6. Any non-residential Park Sportfield user will be required to provide proof of liability insurance coverage. The required Liability Insurance will consist of \$1,000,000 single limit liability insurance naming THCA as additionally insured.
